



Fitzgibbons who presided over the

FACET (Fenland Area Community Enterprise Trust) is a truly local charity based on the Marwick Road Industrial Estate in March, Cambridgeshire. They work with adults with learning and other disabilities from across the Fenland area to give them the same opportunities in life as everyone else in the local community. The charity was launched on 7th June 2002 as a community-based social training enterprise, providing just 15 placements weekly and has now grown to work with more than 100 students every week, which makes them the biggest provider of its kind in the county.

Over time the charity has developed to become a major provider of health and social care services which parents and carers have come to depend on as for many this is the only form of respite available to them. Over time the charity has had to become almost entirely self-supporting. Only by the sheer determination of Board members and the management team has the charity continued to thrive. It now has a reputation of which it is immensely proud thanks to a dedicated staff team of over 30 plus around 20 volunteers who provide invaluable support.

Offering an amazing programme of 17 different forms of training each week including things like Basic Skills, IT, Catering, Horticulture, Woodwork, Art and Craft, Sport and Leisure, Healthy Lifestyles, Music and Movement, Drama etc. the charity also delivers accredited training in Employability Skills and Retail. This enables



students to undertake paid or voluntary work in the local community and to live independently or in supported living as opposed to spending a lifetime in residential care.

The charity's premises house a large woodwork shop, equipped with the full range of power driven machinery. Work is done with local schools to produce play equipment, and also with local businesses. The charity's horticulture project boasts four polytunnels and a large greenhouse. In addition the charity has three charity shops, two in March and one in Chatteris, which offer a furniture recycling service, with collections and deliveries being made throughout the Fenland area.

Readers can help support our charity either by purchasing our plants and woodwork items, donating goods to our charity shop or perhaps by carrying out some voluntary work for us, all of which would be greatly appreciated. Parish Council News

Funding was again on the agenda at July's Parish Council Meeting. This time over how to pay for proposed improvements in the junctions to the 16 Foot Bank road. The "Local Highways Improvement Bid" was up for discussion. It was explained that only one scheme could be put forward each year. It had been the intention of the Council to propose the improvement of the two junctions, by reduction of the speed limit leading to and onto the 16 Foot Bank road. However, following an item brought from the public time at the beginning of the meeting, for a similar reduced speed limit on Euximoor Drove - this alternative scheme was also a possible candidate, so should be considered. Following

some debate a further scheme was also

mentioned - to change signage to prevent Heavy Goods Vehicles coming through the village. With a range of options on the table the Council decided to ask if other proposed schemes could be identified and requested if there were any they should be emailed to the Parish Clerk before the August Meeting. Using:

The Council deferred its decision until the August
Meeting.

Following the CRA meeting a suggestion was made that all of the above issues should be considered under one 'umberella bid' – "Make Christchurch safe!" -Ed'.

Editor's Interview with Connie Symons

Memories of the Old Toll House - Part 1



I first met Connie in the summer of 2008 shortly after I moved to Christchurch, and at a time when Upwell Health Centre still used to run a satellite surgery on Wednesdays in the old village hall. This was how I first got to meet many of the villagers like Neville, Walter, Mary Rolfe, Doris Ted Rolfe, Wolsey and Doris, Lol and many others. Anyway, on this particular occasion, Dr. Millard (Oh how we miss him!) was running rather late, and Connie had been continually glancing at her watch.

"Are you alright?" I asked, "You're looking a little worried"

"Well I'm frightened I'm going to miss me dinner down the pub!" she exclaimed.

We were the last two waiting.

"You go in first, and I won't be long. So I'll walk you down to the pub as soon as I come out." I replied.

"Well that's very kind", said Connie, "I look forward to being escorted by a nice young man!" "I haven't been called that in a long time!" I replied (I was 56 at the time and Connie was 91, though she didn't look it – but she had a few years on me).

And so it was, a little while later that Wednesday, that I escorted Connie down to The Dun Cow for her OAP's lunch; two courses for a fiver; a tradition

that continues currently. Connie never forgot this kindness, and on other occasions, when our paths crossed, I was always referred to as her 'gallant escort'. We had become good friends. Connie endeared herself to everyone.

Well, time has moved on now and after a period of illness Connie now resides at Ashville House, a lovely old folks home just alongside the railway at Downham Market. She is happy there and has many close friends; two especially, Bridget Carter and Sheila Young.

When we produced our 150th Anniversary Souvenir Edition of The New Heron, I'd thought it a good idea to present Connie with a copy as she had been Churchwarden at the time of the church restorations back in 1995. Pauline Hutchins visited Connie regularly on a Friday (still does!) so I asked her if I might accompany her on her next visit. She agreed and thought that Connie would appreciate our idea.

Connie was born in September 1917 in Sutton St. James. When she married Sydney Symonds they had moved into The Old Toll House on Halfpenny Toll in 1938 which also had ten acres of farm land with it. Their son Roger was born there and later Pat their daughter came who became a District Nurse. The family moved to Hillboro on the corner of Halfpenny Toll road in 1952. Sydney died in 1984 but Connie went on living at Hillboro until she became ill in 2012 and later transferred to Ashville House.

Sydney's father Walter Symonds had owned half of The Old Toll House prior to he and Connie moving in, the other half belonged to Mr and Mrs

Brookes. Though it was originally all one building The Old Toll House had been divided to make two homes some years prior to Walter taking on his half. Though the buildings still on the site of The old Toll House were later sold Connie's son Roger still owns eight acres of land surrounding it, including Hillboro Field.

The Halfpenny Toll road finally became a 'free' road on Monday October 12th 1908, after being in the possession of Victoria Lodge of the Oddfellows for ten years and kept by Mr. G. Brookes. It was situated more or less on the Cambridgeshire / Norfolk border. There is still a hump across the road that defines this.

When I handed the 150th Anniversary – Souvenir Edition to Connie having explained why I was there, and what it was, she was delighted, and, with her usual room illuminating smile, she said:

"Oh thank you so much! I shall treasure this!"

It was still proudly displayed, on the table next to her, in her room, when next I visited.

We had chatted about many things on my first visit. Her involvement with the Church, of course, but also her many other activities including being a

member of St. John's Ambulance, and the many amateur dramatic productions she had produced over the years, and floats in the days of the Christchurch Gala. Something she would dearly love to see revived.

We talked about old photographs that were now in safe keeping with her son Roger and his wife Carol who had moved to the original Crown Lodge in Crown Drove when they married in 1973, and are there still. Prior to that the family had had to leave The Old Toll House in 1952 when the gable end facing the road collapsed following a heavy storm. Despite a protracted argument with Norfolk planners they had been refused permission to rebuild. Roger and Carol later provided me with a collection of photographs that would act as an 'aide-memoire' for Connie. One particular photograph Connie had remembered hung on their wall was a large A3 sized photo of The Old Toll House (see below!) complete with a rather well dressed young lady on her bicycle. I would take this and the other photos over to Connie on my next visit.

Film Review

The Monuments Men - Fox/Columbia

Well we are now post D-Day, the Germans are on the run, but they are determined to take anything of value with them; looting art galleries and museums, as well as private collections (often Jewish) for valuable, often priceless, artifacts. In the post-war chaos of the 'clear-up', such a task is relatively easy, and the Germans are very organized; whether working on behalf of The Fuhrer, or for their own personal gain. What they couldn't take they burnt.

Based on the true story of the greatest treasure hunt in history, The Monuments

Men delivers thrilling action, and priceless performances from an all-star ensemble cast of George
Clooney, Matt Damon, Bill Murray, John Goodman, Hugh Bonneville, and Cate Blanchett. With Jean
Dujardin and Bob Balaban adding some local colour, all are marvelous and believable in their unusual roles.

When a team of unlikely – and woefully unprepared – heroes is sent to the front lines of WWII to rescue artistic masterpieces from the Nazis, the race against time; - before everything disappears without a trace; to protect more than a thousand years of culture, begins. The rag-tag band of curators, architects, artists and historians, may not stand a chance... but they're the only chance we've got to protect and defend mankind's greatest artistic achievements.

Somehow they manage to bridge the horrors of the war but not the devious wheeler dealings that seemed to underpin it; especially during the withdrawal. All in all a historical roller-coaster ride through events that actually happened during the closing days of WWII. Underground treasure houses are discovered, some containing more than 16,000 artifacts. It seems that the Nazis thought more of, and took more care of, such items than they did of people.

The Alan Russell Column A History of Euximoor Drove - Pt 2

The Methodist Chapel

The old brick chapel together with the Sunday school room on the side was the home of a really staunch Methodist congregation. Two services on

a Sunday and two or three meetings in the week together with the Sunday school were always well



The old Euximoor Methodist Chapel as was!

attended. The Sunday School Anniversary would be held to an overflowing congregation and on the Monday afternoon the organ would be lifted onto a horse drawn lorry and the choir and children would climb aboard and journey up to Christchurch and return singing hymns and choruses whilst 3 or 4 boys would go round on cycles collecting from houses and very often run over fields to workers hoeing sugar beet etc. Sometimes for your effort some of the less inclined workers would give you a penny. A thriving male voice choir used to go to other churches up to 20 miles away to give concerts during the winter months.

The chapel still had a decent size congregation when after a bad storm the side next to the dyke fell to the evil of "fen subsidence". By this time electric light had replaced the carbine plant and lighting and even a flush toilet had been built. When we were kids we would go into the store holding a carbine plant and put small pieces into a tin with a tight lid and you could make it explode blowing the tin to pieces.

[Hmmm! Should we have printed that? -Ed'.]
I purchased the large banner stating, "God is our refuge and strength" which was hung above the pulpit and have it hung in my ex-potato store.
When the chapel had to close most of the congregation started to use the new Methodist chapel in Upwell. A lovely marble christening font donated by my grandparents family, Earnest and Edith Russell, in their memory to Euximoor Chapel was taken to be used at Upwell but unfortunately after a few years it was stolen and never found again, whether it was just a youthful prank who knows? Because it was heavy some people searched the river running by, but no trace of it was ever found.

As an aside, in my Grandparents bedroom hung two pictures, "The Broad & Narrow Way" and "The Pilgrims Journey" to the celestial city with reference and texts from the Bible and they always fascinated me when I was allowed as a small child to have them down and look at them.

When my grandparents passed away in about 1950 the pictures were given to the Sunday school for others to enjoy as my grandfather has been a Sunday school teacher and Superintendent there for many years and when the chapel closed about 40 years ago I asked if I might purchase them back but when I went to collect them only one was there. The "The Broad & Narrow Way" and for the next 40 years I have searched hundreds of car boots, flea markets, antique shops, charity shops and lately on the internet to no avail until I went into a private museum in Shropshire 3 years ago and there laying with a lot of other 'junk' was the picture I had spent hundreds of hours over 40 years looking for but the lady owner would not part with it. Earlier this year while we were touring around I called at the Museum and took a chance and encouraged by my wife offered a sum she felt she could not refuse after all these years I felt as if I had won the lottery and could not wait to get it cleaned and reframed which my daughter paid for as my birthday present.

The chapel, like many of the houses, was built right on the road side on parcels of "pinched" land but has been demolished, and nothing remains but an overgrown plot and a few photographs of the inside and outside of the building.

Many years ago one of the "Hell, Fire and Brimstone" local preachers got so enthusiastic in his sermon he fell down the pulpit steps and shook himself up badly. The stewards asked if he would like to close the services so they could take him home, he used to cycle everywhere to preach but declined saying "I've got half way through my sermon and gotten Daniel in the Lions Den and if I leave off now the lions will probably eat him!"

A well liked member of the congregation, the late Mr. Leslie Russell used to recite wonderful monologues at some services and knowing I used to enjoy them I can still remember some of my anniversary pieces; his collection of them were given to me. I intend to learn them one day.

Memories are made of this!!!!



HEALTH RISKS OF SNORING

Part 2

Injury

This is one of the more serious dangers of sleep deprivation caused by snoring or sleep apnoea. Daytime sleepiness can be so intense that it puts you and the people around you at risk, says

Doghramji. If snoring or sleep apnoea is leaving you exhausted, you run the risk of falling asleep, perhaps while driving. An analysis of health information and driving data for 618 adults over 10 years showed that the sleepier people

felt during the day, the greater their risk for a car accident. The risk was also greater if people were driving alone.

Mental Health Issues

Sleep apnoea can affect your mental well-being, leading to issues from crankiness from a lack of sleep to serious depression, Doghramji says. In fact, the link between sleep apnoea, snoring and depression is well established. A recent study of 74 snorers showed that the more daytime sleepiness people report, the greater their chances of also having mild depression or anxiety symptoms. Researchers are still untangling this relationship, but treating sleep apnoea does seem to help ease depression.

Headache

Do you often wake up with a headache? It's not just from your spouse complaining about your snoring. According to a recently published study of 268 people who were habitual snorers, researchers found a connection between frequent morning headaches and sleep disorders including insomnia and sleep apnoea. Snorers with frequent headaches reported a lower quality of life than those whose heads did not hurt.

Nocturia

Getting up to use the bathroom two or more times a night is a condition called nocturia. For some people, this includes a loss of bladder control. It is also linked with snoring in both men and women. Research suggests that men over the age of 55 who wake up often to urinate may have both benign prostate enlargement and obstructive

sleep apnoea. Another study showed a strong link between the two conditions.

Less Sexual Satisfaction

A study of 827 older men found that the more and the louder they snored, the more likely they were to

report lower levels of sexual satisfaction, even though a clinical analysis of their health did not show physiological signs of reduced sexual response. Many people are so affected by their snoring that they don't have the desire for intimate relations with their spouse, explains Doghramji.

Treatment for sleep disorders can usually get you back into the game.

Foetal Complications

Snoring during the last trimester of pregnancy is usually due to weight gain. Of greater concern, says Doghramji, is that this snoring is also accompanied by an increased risk for foetal complications. The connection isn't clear yet, but it might not be surprising given the way that interrupted sleep appears to negatively affect almost every aspect of health. Women who snore loudly during pregnancy should talk to their family doctor or obstetric gynaecologist.

Excess Weight

Half of overweight people also have sleep apnoea, says Doghramji. This is partly because of the extra weight that collects around the neck, making it harder to keep breathing at night. The good news is that losing weight improves symptoms related to sleep disorders. If you're overweight and your spouse or other family members tease you about snoring, talk to your doctor about a referral to a sleep specialist. Whether your snoring is light and lovely, or orchestral, treatment will get you (and your family) back to sleep.

Did you know?

Some of the lumps and bumps in the Fenland landscape are known as "roddons". A roddon (or rodham, roddam or rodden) is the dried bed of a fenland watercourse where surrounding peat lands have dried and shrunk leaving the silt-filled river bed and banks as a raised ridge. Roddons make good firm land for buildings and roads, and Silt Road which runs from Lott's Bridge to Nordelph did not get its name by accident.

Richard had a phone call earlier in the evening from John Elworthy, Editor of Cambs Times, to say that he had been contacted by the leader of FDC confirming that £100,000 had definitely been earmarked and set aside for the new building. John was currently preparing an article on this subject which would be available online by the next day (Thurs 20th) and published in next weeks Cambs Times.

The petition re Jackson's Corner had so far gained more than 100 signatures from the village and Sara Russell would hold it open until the end of July and then send copies to FDC and Highways together with a covering letter. Work on the 16 Foot Bank had now been completed though it overran the original schedule by a week.

Despite an appeal in The New Heron for more coordinators for Neighbourhood Watch no additional persons had, so far, come forward. So it was agreed that we would start the scheme just in Church Road to start, with the four volunteers we so far have, and hope that this would, eventually, encourage other parts of the village to participate.

Several residents complained about the over zealous nature of the recent "village inspection" by councillors. Unnecessary letters had been sent out causing unneeded and avoidable angst to some residents.

Richard had been contacted by Steve Waye regarding fundraising for The New Heron. He had

suggested a concert and kindly volunteered his services – "HERONAID" (see page 3) will be held on Saturday September 20th in Townley School Hall from 7.00pm and food will be available during the interval thanks to Friends of Townley.

Terry Symons gave us an update on the proposed development F/YR14/0023/ for two new houses, south-east of The Paddocks in Green Lane. He read out correspondence that he had been having with Sheila Black of FDC Planning. This was very jargonistic and contradictory. However, Terry would continue the fight and hoped for a meeting with Sheila Black in due course.

Finally, and in conjunction with the above, our Chairman related a detailed telephone conversation he had had with Susan Bull, Planning Liaison Manager for Anglian Water. She had not been able to attend our meeting as she had only just returned from holiday but she had promised to look into CRA concerns re the number of current planning applications that had been granted for Christchurch considering that the sewage plant that serves the village is already under-capacity for the homes it currently serves. The system is already 'overloaded' and cannot cope. There have already been a number of sewage related incidents in the village. Susan Bull has promised to provide a full and detailed response to CRA by the end of the month.

The meeting closed at 9.00pm. Next meeting 10th September at The Old School 7.30pm. Any other villagers are welcome to attend.



Are you a - Responsible Dog Owner?

I am a dog lover. In fact I'll go further than that. For the last six years I have worked as a rehoming inspector for a dog rescue centre which specialises in border collies and working dogs, but does have other breeds as well from time to time. My own dog "Dubh" - who you've probably 'heard' at The Old School – she does have rather a loud bark! – is a Border Collie x GSD; but is really very gentle and friendly. She used to be excellent at agility, though we haven't done it for a few years now. My other half also has two Border Collies "Ty" and "Tia".

In September last year I successfully rehomed a miniature spaniel bitch to a couple in Manea. She only had one eye and had been brought over all the way from Spain. She settled in brilliantly within a week and now rules the roost. Last March we rescued a beautiful 'blue merle' Border Collie from Woolwich, who is now called "Stormy" (very appropriate) and now lives with a young couple, Johnathan and Kate, who are my opposite neighbours in Church Road. So, though I may not know everything, I do know dogs.

Do you pick up after your dog?

Until recently I believed Christchurch to be a very 'dog friendly' village. People, even non-dog owners, and dogs, getting on well. We have had a large influx of new dog owners in recent months, particularly with some of the more unusual exotic breeds including: Blue Merle Border Collie, Japanese Spitzer, beautiful Borsoi, Cockerpoo, Blue Roan Cocker Spaniel, Chinese Crested, and even a Caanan. All the owners of the dogs I have mentioned are very conscientious and responsible dog owners. In particular they CLEAN UP AFTER THEIR DOGS!

Sadly, it seems that one or two other dog owners are either just plain 'lazy' or think it's perfectly OK to leave 'dog mess' outside other people's houses with no thought of clearing it up with a simple doggie poo bag. Only two days ago I had to take a bucket of water and stiff yard brush to a particularly 'squitty' mess outside a neighbours house, even though my dogs were not responsible. Those that don't 'pick-up' are alienating us all with villagers who are not dog owners; as we all tend to get tarred with the same brush! You can't blame them!

If you own a dog there are certain responsibilities that come with that. Number one being basic training of your pooch, and yourself, making sure you

24 always have poo bags with you so that you can

easily turn them inside out, clear up, tie up, and not get yourself dirty in any way. OK! Leave the knotted bags to the side of the road for collection on the way back from your doggie walk. But, DON'T FORGET!!! Don't forget to have the necessary bags with you, and to 'pick up' afterwards!

Lazy and inconsiderate dog owners are giving the rest of us a bad name! It's not the dogs that are at fault but the owners. Saying that dogs are dirty is simply 'punishing the wrong end of the leash'!. It is the owners who are at fault! It's them that need the training. My own dog is trained <u>not</u> to do her 'number twos' on tarmac or pavement, so we never have any 'accidents'. She waits until we are past all the houses on Green Lane and reach the farmland. But I still have poo bags with me!

Please all you doggie people PICK UP AFTER YOUR PETS before we are ankle deep in the stuff!

Does your dog bark too much?

All dogs bark, but if yours goes on all day or night, and the barking is upsetting your neighbours, it might be not only courteous, but also wise to take action. Dogs bark to communicate with each other and us, and no one should expect to have a completely silent dog. It is unreasonable to expect dogs to be quiet if there is a knock at the door, for example – it is their duty to tell us someone is there! And living in the country as we do, most people not only own a dog for the company as a pet, they are a very good early warning system to alert us to possible changes around us. However, problems can arise when a dog barks excessively. Some people cannot tolerate persistent sounds and not only just find them a little annoying but can become something that causes them extreme stress and upset. Eventually causing an issue even when the dog isn't actually barking, just the not knowing of when it will start again and not stop can become an obsession and very stressful! If you think, or have been told that your dog barks more than is usual, the first step is to consider why it is barking.

Is it uncomfortable, or in pain? Is it bored? Is it barking because it's been left alone and is trying to call you back? Or, if your dog is only left for short periods, has he or she become overdependent on you?

- If your dog barks at things outside in your yard or garden, don't let it go outside on its own.
- Keep it away from windows, so it can't see people or other animals.

- If your dog barks at the same time every day, like when people in the house are going to work or school, try to keep it busy at that time.
- If it barks when it's excited, don't play with it at anti-social times like very late at night or at times when you think others might be enjoying a snippet of limited peace and quiet.
- Don't leave your dog outside if it's barking to be let in, or if it is trying to alert you to something.
- Having a dog as an outside burglar alarm isn't much good if you don't pay attention to the alarm, lets face it when your car alarm goes off do you ignore it and carry on watching the TV?
- See if you can get a friend or relative to look after your dog when you go out, or take it with you.
- Make sure your dog gets some regular exercise.
 A tired dog barks less.

Something to bear in mind

If you don't take steps to solve the problem, and your local authority receives complaints about the noise your dog is making, the authority has a legal obligation to investigate the complaint. Where mediation by the Local Authority is unsuccessful, and they are satisfied that the noise amounts to a statutory nuisance, they will serve you with an abatement notice requiring the noise to be reduced to an acceptable level. If you fail to comply with an abatement notice, you could face prosecution and, if convicted, a fine of up to £5,000 (and possibly further daily fines of up to £500 for each day on which the offence continues after conviction). You may even be forced to attend dog training classes at your own expense!

I hope that all you responsible dog owners will appreciate the following poem, and I hope that others might take note and learn from it!

The Kindly Canine

Boxer dogs aren't boxers, Nor do terriers terrorise, It's us humans that love bloodsports; THAT's why the Pit Bull still survives.

Hare coursing and fox hunting Are games made up by man, And man's best friend will please him; Any way he can.

So what of the dangerous dogs act?
~ One for dangerous owners too?
For a trained dog's a healthy brained dog;
Why not train owners to use THEIRS too!!?

So don't malign old four legs, It's two legs that are bad! It's OUR genetic manipulation That makes those doggies mad.




